

**SCHOOL DISTRICT OF MARSHFIELD**  
**PERMIT TO HUNT ON SCHOOL FOREST PROPERTY (832.1)**

I understand and recognize that the School District of Marshfield is not required to permit me to hunt on School District property. I recognize and agree that the right to do so is a privilege, which can be revoked at any time, with or without notice. In consideration of the School District's agreement to permit me to hunt on its school forest property, as identified below, I hereby agree to the following:

- 1) I will abide by all state and federal laws while hunting on school forest property including, without limitation, laws applicable to firearms and hunting.
- 2) I will not litter on school forest property or disturb the natural habitat of the school forest,
- 3) I will shoot and hunt only game authorized by this permit on the school forest property. I will not harm any other game or animal,
- 4) I will exercise due and proper care while hunting on the school forest property,
- 5) I will abide by all School District policies and procedures while hunting on school forest property. A copy of the specific rules pertaining to hunting on school forest property is attached,
- 6) I will not permit any individual who has not been granted a permit by the School District to hunt on the school forest property to hunt with me while I am doing so, and
- 7) I hereby waive and release, and agree to indemnify, defend, and hold harmless, the School District, its officers, employees, and agents, from and with respect to any claim, loss, liability, injury, penalty, harm, or damage of any kind or nature whatsoever, including but not limited to that occurring to myself, arising out of my hunting activities on school forest property, including, but not limited to, compensatory, incidental, consequential, and punitive damages. This waiver and release, and indemnification provision applies without limitation to any claims or causes of action based upon acts or omissions of the School District, its officers, and employees, including, without limitation, the district's granting permission to hunt on the school forest property and my hunting on that land. By signing this Permit, I also waive and release such claims against the School District, its officers, employees, and agents, on behalf of my minor children, if any, that have also been granted permission to hunt on school forest property and with whom I will be hunting and will be under my supervision.

## Additional Points of Emphasis:

- Application to hunt must be on file in advance of proposed hunt.
- **Only one applicant per permit.**
- **If the main gate on County N is open, then the permit is null and void. (Except during Regular Gun Deer Hunting Season)**
- Hunting stands must be taken down daily.
- The Orange Marshfield School Forest Hunting Permit must be displayed in your vehicle.
- Do not block the main gate.
